The Origin of The Midwest Sociological Society Charles N. Burrows

Charles N. Burrows was one of the founding members of the Midwest Sociological Society. Here he describes the difficulties attendant to organizing the first meeting. Reprinted from *The Mid-West Sociologist*, Volume VIII (December, 1945), pages 4-5.

The Iowa Association of Economists and Sociologists was organized in 1916, with Dr. Norris A. Brisco of the State University of Iowa as the first President. With the exception of 1918 and 1919, annual meetings of this association were held through 1935. About 1931 or 1932, the Mid-West Economics Association was organized. The first three or four meetings of this association were held outside the State of Iowa. Being held outside the state, this association did not seriously interfere with the attendance of the Iowa Economists at the annual meetings of the Iowa Association of Economists and Sociologists. The Economists were always considerably more numerous than sociologists in the membership of the Iowa Association.

The Mid-West Economists decided to hold their 1936 annual meeting in Des Moines. I happened to be President of the Iowa Association of Economists and Sociologists that year. It seemed very doubtful that the Economists of Iowa would be willing to attend the Midwest and the state meeting. I personally conferred with Dr. E.B. Reuter, Dr. F.E. Haynes and Professor Clyde Hart of the State University of Iowa, and with Dr. Ray Wakeley of Iowa State College. The problem of holding the 1936 annual meeting of the Iowa Association of Economists and Sociologists was considered, with the recognition that the attendance of the Iowa Economists at such a

meeting would most probably be very small. The Iowa Economists would all wish to attend the session of the Mid-West Economics Association. Consideration was given to the advisability of attempting to organize a Mid-West Sociological Society to somewhat correspond to the Mid-West Economics Association. It was agreed that this was probably the only way to meet the situation that year, and it was decided to call a meeting of the sociologists at Des Moines for the dates on which the Mid-West Economists were scheduled to hold their annual meeting at Des Moines. This date was April 9-11, 1936. Letters were addressed to the Head of the Department of Sociology at every University and College in the State of Iowa, and in all the states surrounding Iowa plus North Dakota and Kansas. These included the Sates of Iowa, Missouri, Kansas Nebraska, South Dakota, Minnesota, Wisconsin and Illinois. number of letters were also addressed to instructors of sociology at several of the junior colleges. The letter included an announcement of the meeting, an invitation to attend, a request that other members of the staff be brought along, and an inquiry as to what person or persons on the staff might have something to present on the program. A splendid response was received both for attendance and for program material. Some 75 delegates were in attendance, about 40 of these being from outside the state of Iowa. The program was in every way quite superior.

The Roots of the Midwest Sociological Society

It is in many ways difficult to imagine the sense of collegiality, professionalism and sense of purpose that characterized the first meeting of "The Sociologists of the Mid-West." That was the organizational name that appeared on the program in 1936 when sociologists in the Midwest first came together as a separate organization.

The roots of the fledgling organization rested in the *Iowa Association of Economists* and *Sociologists*. That organization met first in 1916 at the University of Iowa, and met annually through 1935, (with the exception of 1918 and 1919), at colleges and universities across the state. In 1931 or 1932, the economists of the Midwest formed a regional association, an action that seemed to threaten the existence of the *Iowa Association of Economists and Sociologists*.

In an effort to preserve the opportunities for professional engagement, Iowa sociologists, led by Charles N. Burrows, contacted sociologists at colleges and universities throughout the nine states that currently constitute the Midwest Region, asking that they

meet in Des Moines to present their research April 9-11, 1936. The Twenty-first Annual meeting of the *Iowa Association of Economists and Sociologists* was held "in conjunction with" *The Mid-West Economics Association* and the *Sociologists of the Mid-West* on those dates, at the Fort Des Moines Hotel in Des Moines, Iowa.

The First Programs of the MSS

The "Sociology division" in 1936 offered five sessions, lasting from two to three hour each, a business meeting and a banquet. The banquet was held jointly with the other organizations mentioned above and with the Iowa Branch of the American Association of University Professors.

Sessions in 1936 did not have titles and only one session reflected a theme, with papers on juvenile delinquency, drug addiction, and identification of criminals through fingerprinting. Most participants in the 1936 program were from Iowa schools including the University of Iowa, Iowa State College at Ames, Simpson College, and Grinnell College. But presentations also were made by faculty members from the University of Nebraska at Lincoln; Sioux Falls College at Sioux Falls, South Dakota; Knox College, Galesburg, Illinois; Nebraska State Normal College at Chadron, Nebraska; University of Missouri at Columbia; Creighton University at Omaha, Nebraska; and the College of St. Thomas at St. Paul, Minnesota. Thus, six of the nine states that presently constitute the Midwest region were represented among participants at the first meeting. To the extent that gender can be discerned (in several cases only initials are used), one woman participated in this first meeting. She was Laetitia M. Conard from Grinnell College. That year the association dues were \$1.00.

In 1937 Mid-West Sociologists met at the New Kirkwood Hotel in Des Moines, Iowa from April 15 through 17. The program underwent major changes from the first gathering to the second, with seven sociological paper sessions, and one joint session with the Mid-West Economic Association. All sessions lasted one and one-half hours, and during one time slot, two sessions were held concurrently.

Paper sessions in 1937 were thematic and included "Sections" on Rural Sociology, Social Psychology, The Family, and Ecology and Population; "Forums" on Juvenile Delinquency and on Research; and a "Symposium" on the Social Psychology of George Mead. Participating in these sessions were sociologists from Iowa, Illinois, Nebraska, North Dakota, Missouri, Kansas and Washington. Economists from Minnesota also were

present. Names of several participants might be recognized today, particularly as they relate to disciplinary specialties. Those included E. W. Burgess, Saul D. Alinsky, J. O. Hertzler, Ellsworth Faris, E.A. Ross, S. A. Queen and Noel P. Gist.

In addition to these sessions and the joint session with the economists, the participants in 1937 held a banquet with the economists, a business meeting and three committee meetings - including Committee on Local Arrangements and a General Committee. The still formative nature of the organization is indicated by the title of the third committee - "Character of proposed Mid-West Sociological Society." The agenda for the committee included "Place of Meeting and Nominations. This committee title is the first recorded use of the current organizational name.

Meetings of the MSS were held in Des Moines through 1947, presumably because of its roots in the Iowa Association and because of the geographic centrality of Iowa in the region. No meetings were held in 1943 and 1945. Since then, meetings have been held in various Midwestern cities.²

Early Years through The Mid-West Sociologist

Some understanding of the early years of the Midwest Sociological Society can be gained from issues addressed in *The Mid-West* Sociologist, the initial newsletter of the organization. In the February 1939, Volume I, No 1 of *The Mid-West Sociologist*, President Noel P. Gist commented on the state of the society and reflected on the relationship of this new organization to the American Sociological Society.

"Just three years ago the "founding fathers" of the Mid-West Sociological Society were laying plans for a regional organization. Today that organization has become a reality. One of a half dozen regional societies in the country, it has arisen to meet the needs of professional sociologists in the Mid-West region.

While the original problems of the organization have, in the main, been solved, new questions of organization are being raised. So far, the relations between the American Sociological Society and the regional societies have not been worked out satisfactorily. Yet all will undoubtedly agree that some arrangement is highly desirable. For this reason a committee will be appointed to explore the possibilities of a regional-national arrangement and to present its findings and

recommendations at the spring meeting. It is hoped that between now and then the members of the Society will give the matter serious consideration and come prepared to deal with the problem."

The remainder of the newsletter was devoted to information about the Committee on Research, the annual meeting program and to notes about activities at institutions in the Mid-West.

Volume II, Number 1 appeared in June 1939. Notes in that volume pointed to growth in the Mid-West Sociological Society with an estimated 145 persons registered for the meeting in Des Moines, up 25% from the previous year. The MSS already was serving students, as about 40 of the registrants were undergraduate and graduate students, and a Student Sociological Society was mentioned in this and in future programs. The issue also notes that five Past Presidents of the American Sociological Society attended the Mid-West meetings this year, "namely: J. M. Gillette, E. B. Reuter, L.L. Bernard, F.S. Chapin and Ellsworth Farris." By this 1939 date the MSS claimed 152 members, of which 25 were sustaining and 54% were members of the American Sociological Society.

The relationship to the American Sociological Society was an important issue for this fledgling organization, and apparently for other regional organizations as well. At the 1939 MSS meeting "The following action on Regional-National Relations was taken.

- 1. That the American Sociological Society should be looked upon as a federation of regional societies a well as a purely national society.
- That the national society arrange for joint membership at a standard fee, a portion of which is to be returned to the regional society as the regional fee of a member."

The November 1939 issue of *The Mid-west Sociologist* reported on the continuing work of the "Research Committee" and on the fact that the "Committee on Organization of the National Society" would present a scheme for the reorganization of the American Sociological Society at its meetings in Philadelphia. A focus on teaching in the regional societies already was apparent, as a lengthy report in this issue summarized a report from the Ohio Valley Sociologist Vol. XII, No. 3 on a study of "the development of Sociology curricula." In addition the 1940 program included two sessions on teaching – one for High School Teachers and the other focused on the role of the Student Sociological Society.

The 1940 meeting was a joint meeting with the Mid-West Economics Association. All sessions carried titles corresponding to fields within the discipline (Criminology, Social Psychology, Rural Sociology, Sociometry, The Family, Sociology and Social Work, Regional Research, Rural-Urban Research, Educational Sociology) with many having specific sub-topics identified. That meeting saw 140 registrants, a 70% increase in attendance. Student attendance increased from 32 the previous year to 83. Dues for regular members was \$1.

During the early 1940s *The Mid-west Sociologist* carried a great deal of news of the activities of members in relation to the war. Volume V, #3 carried news from President James M. Reinhardt that the 1943 meetings were canceled.

"It is a matter o keen regret to me that a decision to abandon plans for the April meeting of the Society became necessary... The decision was made inescapable by advices received at the end of January from the Office of Defense Transportation, and by a consideration of the difficulties confronting the Society in the way of securing hotel accommodations in Des Moines."

The remainder of the issue focused on news about various research groups that had been working on sessions for the canceled meetings.

In 1944 member sentiment was strong that a meeting should be held, and by 1944 meeting themes emerged. In that November 1944 newsletter, President David Lindstrom presented several ideas received from members for the theme of the meeting. The most support seemed to be garnered by "Social Change in Wartime." The 1944 meetings were held April 22-23, 1944 at the Kirkwood Hotel in Des Moines. The meeting was held on a Saturday and Sunday due to "the fact that many of our members engaged in military teaching programs could not attend at any other time." But there was no meeting in 1945. Since 1946 the Midwest Sociological *Society has met annually*.

The Role of The Mid-West Sociologist

By June 1941 (Vol. VI, Number 1), the fact that *The Mid-west Sociologist* would move toward scholarly activities was apparent with the listing of an editor, acting editor and seven member editorial board. In that issue, the Editorial Board page carried, among other notes, a request that members "submit for publication brief papers and summaries of research." From then on, at least one issue of *The Mid-West Sociologist* each year carried summaries of ongoing research. The September 1947 issue, with the exception of reports

from the secretary and treasurer, was devoted entirely to abstracts of papers presented at the previous annual meeting. Many of those papers focused on teaching in the discipline, both content and pedagogy. By 1948, most issues of *The Mid-West Sociologist* were devoted to abstracts of presentations and to short articles. By 1949 *The Mid-West* Sociologist was devoted almost entirely to scholarly pieces. Among articles in the fall 1949 issue was "The Position and Prospects of Sociology as a Professional Field" by Talcott Parsons." That issue also carried ads from several book companies, a practice that continued for many years.

In spring 1954, Volume XVI, #2 of *The Midwest Sociologist* for the first time carried the subtitle "Official Journal of the Midwest Sociological Society. That is the first issue that appears to be typeset, rather than typed. It carried longer articles and was very much in a journal format. No further issue of *The Midwest Sociologist* are available at this writing. But in January 1960 the first issues of both *The Sociological Quarterly* and *Newsletter: The Midwest Sociological Society* appeared. The early issues of the *Newsletter* were devoted primarily to news about sociology departments and members throughout the Midwest, as well as to news about the annual meetings.

The History of the MSS through Committees

At the time of the first meeting of the Midwest Sociological Society in 1937 several committees were listed in the program. From 12:00-1:30 pm on the only full day of the meetings, three committees – "Character of Proposed Mid-West Sociological Society," "Place of Meeting," and "Nominations" – met to plan for the future of the organization. The program also listed a "Committee on Local Arrangements," undoubtedly comprised of those who had planned the 1937 meeting.

Newsletters carried information about committees until 1942. During those years committees that attended to the organization of the fledgling professional society dominated. These include local arrangements, executive and nominations committees, as well as public relations, and transportation committees. Other committees perhaps reflected the dominant issues of the time. A committee first called "Committee on Organization of the National Society" and later "Committee on Regional-National Relations" reflected the struggle over what should be the relationship between the American Sociological Society and the regional associations.

One committee that emerged in 1939 had a great deal of influence on the direction of the MSS, including on the themes of early meetings. In 1941 the Committee took over publication of the Midwest Sociologist.

The committee structure evolved with consonant with changing emphases of the organization as well as changes in political culture. But through the years several basic types of committees have guided the MSS; committees charged with ensuring that the Society maintains itself and fulfills its basic functions; committees that deal with issues related to sociologists and their professions; and committees that arise in response to national and international political and social issues.

Committees that Maintain the Midwest Sociological Society

Executive Oversight

Until very recently (about 1999) the Midwest Sociological Society was a totally volunteer organization. Elected and volunteer officers took care of all aspects of the Society's business. An "Executive Committee" appeared in 1940. From 1971 through 1980 the Crisis Committee, comprised of the President, Past President, Secretary and Treasurer took care of any unforeseen needs that arose. While no committee is listed in programs from 1981 to 2002, the Crisis committee continued de facto during that time. In 2003 the Executive Committee, comprised of the immediate past president, the president and the president-elect emerged to provide a decision-making body between meetings. The Executive Director, Secretary and Treasurer serve as requested on the committee.

Membership

The "Membership Committee" appeared in 1963 and continued through 1970. There was no record of the committee for a few years, but it reappeared in 1982 at which point it was comprised of the elected Directors representing the states of the MSS. It has continued to operate with the MSS Secretary as chair and the state, at-large and student directors serving as the committee charged with recruiting members to the MSS.

In 1972 and 1973 the program listed an "Ad Hoc Sustaining Member Committee." The charge of that committee is unclear but sustaining memberships had been part of the MSS since 1939 when 25 members were listed in that category. For the past few decades sustaining membership has been important for ensuring the financial viability of the MSS.

Finances

Oversight: Committee attention to financial concerns was sporadic for much of the history of the Midwest Sociological Society. An "Auditing Committee" existed from 1962-65 and probably before. In 1963 a "Committee on Business Affairs of the MSS" was listed. Then for many years the financial concerns of the MSS were left solely in the hands of the Treasurer, with varying degrees of success. In 2000, after the unexpected and sudden death of the MSS treasurer, an "Ad Hoc Finance Committee" was formed. And in 2001 the "Finance Committee" became a permanent committee that oversees the financial policies and practices of the MSS. This committee continues to work with the MSS Treasurer to guide financial decisions.

Fundraising: For many year, the primary source of MSS funds was from publisher advertising in the annual meeting program and exhibits at the annual meetings. The "Exhibits and Advertising Committee" (see Planning the Annual Meeting) sought to maximize the number of exhibitors and number of ads in the annual program book. Those revenues became less sustainable as publishing houses merged, the number of publishers declined, and other means of contacting faculty about new books became more effective. In more recent years contracts for publication of The Sociological Quarterly have provided significant revenue to support the journal as well as other MSS activities.

Membership dues have long provided financial support for the MSS, even when dues were low. For many years, MSS dues were \$1 per year. This apparently was sufficient to support the activities since in 1943 income was \$224.31 with total expenditures of \$91.33. And when a cash balance of \$315.15 was reported in 1944-45, no dues were charged for 1945-46. But through most of its history the MSS has sought to build financial resources to sustain its programs. In 1970 an "Ad Hoc Committee on Unexplored Sources of Revenue" was appointed and in 1972 the "Ad Hoc Sustaining Member Committee" was established and continued for two years. The committee was charged with increasing the number of members who were willing to support the MSS by paying higher "sustaining" level dues.

The early 1980s brought significant financial challenges for the MSS. For several years expenditures had exceeded income. The 1980 financial report showed income of \$32,563.29 and expenditures of \$36,419.45. While the Society held a small fund balance, concerns arose about the sustainability of the finances. Dues for regular members doubled in two years, from \$10 in 1979 to \$15 in 1980 and \$20 in 1981. Dues increase have been

more gradual in recent years and in 2007 dues were \$44 for regular professional members. In 2011 members voted to raise the dues to \$60.

Annual meeting registration fees also have been a source of income for the MSS. Through the years the MSS has had a philosophy of trying to support meeting expenses with registration fees and other sources of meeting income.

Focused efforts to raise money for the MSS emerged with establishment of the "Endowment Committee" in 1985. The committee benefited from the drive and leadership of Harry Crockett, after whom the MSS Endowment was later named, and later from Helena Zaniecki Lopata. For many years the Endowment Committee sponsored Jazz Night at which MSS members played instruments of choice. Howie Becker was the longtime favorite on the piano, drawing hundreds to listen to music and share social time. The Committee also sponsored various fundraising efforts from selling mugs through T-shirts. For two years, 1985-86, a separate Bequest Committee existed to support the efforts of long-time member Betty Havens to make bequests a significant long-term form of support for the Society.

Planning the Annual Meetings

As was true in 1937, throughout MSS history a primary task for committees has been planning the annual meetings. These committees have addressed four types of tasks – planning the meeting program, planning for local arrangements, organizing exhibits and advertising for the meeting, and planning and contracting for future meeting sites.

Program Planning: The first listing of a "Program Committee" in the meeting program was in 1974. Prior to that time it is likely that programs were planned by program chairs with some assistance from close colleagues. Starting in 1974, a formally constituted committee assisted the President-Elect in the task of organizing sessions and other presentations for the meetings.

Local Arrangements: From the first meeting of the MSS, a "Local Arrangements Committee" has been responsible for on-site arrangements. These responsibilities have included working with the hotel to ensure appropriate set-ups and guest room arrangements, handling pre-registration and on-site registration, generating restaurant guides and staffing employment centers, ensuring that AV needs are met, and generally taking care of member needs during the meetings. In about 2000, the Executive Office assumed responsibility for pre-registration relieving this committee of the most onerous of its tasks.

Exhibits and Advertising: The "Exhibits and Advertising Committee" first appeared in a program listing in 1974 and was listed again in 1991, continuing through 2006. During 1975-1990 an individual ensuredf that Exhibits and Advertising needs were addressed. During the time that publisher exhibits provided a vital source of income for the MSS, as well as important professional contacts for members, the committee was time-consuming and important to the MSS.

Planning for Future Meetings: Vital to the success of the meetings is the task of planning future meetings. Typically hotel contracts must be signed five to six years in advance, requiring a chair who tracks emergence of new hotels (and closing of old ones) and works carefully to secure the best possible rates and arrangements for the MSS. The importance of this task was recognized early with the emergence in 1972 of an "Ad Hoc Committee on Long Range Convention Contracts." The next year the "Committee of Consultants on Local Arrangements" appeared, to be in 1974 by the "Committee of Consultants on Future Local Arrangements." This Committee continued until 1991 when the "Future Sites and Arrangements Committee" was formed. That committee continued until 2007 when the Annual Meeting Committee was formed combining Future Sites and Exhibits and Advertising under the umbrella of a single committee.

Leadership and Planning

Nominations and Elections: Over the years the title of the committee responsible for these activities has changed frequently. A "Nominations and Elections Committee" was among those that appeared in the 1937 program. In 1940 it was titled "Nominations Committee" but by 1962 returned to the original name only to return from 1981 through 1990 once again to "Nominations." In1991 reverted to "Nominations and Elections," the title in use today. This vacillation perhaps reflects attempts to convey the responsibilities of the committee. For many years the committee was charged with bringing forth a slate of nominees for the offices of the MSS and with overseeing the election process. In more recent years, the elections process has carried out by the Secretary and later the Secretary and the Executive Office.

Bylaw and Constitution Committees: In 1962 and again in 1970 "By-Law and Constitution Revision" committees were listed in the MSS programs. Presumably these committees were charged with creating the bylaws in 1962 and revising in 1970. With establishment of the "Long Range Planning Committee" in 1971, these responsibilities were shifted to this standing committee.

Long Range Planning: Planning for the future of the MSS has long been a priority for the MSS. In 1971 a "Committee on Long Range Planning" appeared and continued for three years, then reappeared in 1982. This Committee is staffed, according to the bylaws, with many members who have a long history and understanding of the Society as well as by those who bring fresh perspectives to planning. The LRP Committee reviews bylaw changes and takes actions to ensure the viability of the Midwest Sociological Society.

Definition of the "Midwest" Region and Relation to the ASA

The relationship with the American Sociological Association was from the outset an issue of concern to members of the MSS. In 1939 and 1940 a "Committee on Organization of the National Society" and in 1940 and 1941 a "Committee on Regional-National Relations" appeared in the program, and many comments in the Mid-West Sociologist spoke to this issue.

Delineation of the region that comprises the Midwest Sociological Society also has long been a point of contention. When the MSS was formed in 1936-37 nine states were included – Illinois, Wisconsin, Minnesota, Iowa, Missouri, Kansas, Nebraska, South Dakota, and North Dakota. These states presumably were selected on the basis of proximity to Des Moines, IA, the home of the MSS meetings from 1937 through 1947.

These states continue to define the Midwest Sociological Society region. But the membership of the Society has always been drawn from a much broader geographic area, and through the years some constituencies have lobbied to expand the MSS to include the states that comprise the Ohio Valley association, and others to include Colorado.

These pressures and dilemmas are reflected by committees listed in annual programs, including in 1962 a "Committee on Expansion of the Region," in 1966 a "Committee on Organizational Relations," and in 1968 a "Liaison with Ohio Valley Sociological Society Committee." In 1970 there was an "Ad Hoc Committee to Evaluate Joint Meetings" and in 1977 an "Ad Hoc Committee on Extraterritorial Representation." In 1989 some resolution of the issue was achieved with the addition of an "At-Large Director" to the Board. And in 2007 the MSS and North Central Sociological Association initiated occasional joint meetings.

Publications, Research and Scholarship

Volume 1, #1 of the *Mid-West Sociologist* in 1939 carried a report from the "Research Committee." It reads

"Following the suggestion of Earnest W. Burgess at the 1938 meeting in Des Moines, the Research Committee has chosen to lay special emphasis this year upon cooperative effort. The program for the Research Section of the 1939 meeting will be built definitely around the idea of cooperation. In addition the Committee is promoting cooperative work on the general problem discussed by Burgess in 1938, namely, The Ecology of Mental Disorders. Work is being done in four cities by members of the Society and their associate in four universities."

The "Publications Committee" was in place by 1962. This committee has long been an important, and somewhat privileged committee in the MSS in that it is the only committee that independently solicits nominations and selects its own members (with confirmation by the Board). The responsibilities of the Committee have evolved over the years. For many years the committee focused on oversight of selection of editors and publication of *The Sociological Quarterly*. By the 1970s the "Publications Committee" began to sponsor and oversee the Student Paper Awards as part of its core responsibilities. Only in recent years has the Committee assumed responsibility for *The Midwest Sociologist*.

Committees also convey consistent attention by the MSS to enhance research opportunities for members. In 1963 and 1964 the MSS supported a "Committee to Explore New Research, Career and Service Opportunities in Sociology." In 1966 an Ad Hoc Committee on the State of Field Papers and Special Programs" appeared in the program. In 1973, there was a "Committee on Improving Publications Outlets." Given its one-year existence it no doubt would have been an Ad Hoc Committee. In 1987 through 2004 "The Scholarship Development Committee" offered small grants to support member research projects.

Committees Governing the Profession

Over the years, a number of MSS Committees have taken on the tasks of providing governance and guidance to member sociologists relating to issues that have dominated the profession.

Academic Freedom, Responsibility and Ethics: The history of MSS Committees reflects consistent attention to ethics as well as to academic freedom and responsibility. Names of committees dealing with these issues reflect more than any other fluctuating values and ideals of MSS members.

The "Committee on Ethics" was listed in the 1963 program and the "Committee on Ethics and Academic Freedom" in 1965 and 1966. After a gap of a few years, the "Committee on Freedom and Responsibility in the Profession" was identified in 1974, to be replaced from 1975-1990 by the "Committee on Academic Freedom and Responsibility." In 1991, this committee was renamed "Academic Responsibilities and Freedom," a name it maintained through 2001.

In 2002 professional concerns and responsibilities became part of the committee title again with appointment of the "Academic Freedom, Responsibility and Professional Concerns Committee" which lasted for two years. In 2004 and 2005 the "Academic and Professional Standards Committee" appeared, to be followed in 2006 by the "Professional Issues and Standard Committee," the title that continues at this writing.

Standards of the Profession: Some of these committees have dealt primarily with professional standards. In 1968 the "Committee on the Profession" was established then was replaced in 1975 by the "Committee on Standards, Training and Employment" which continued through 2002, charged with constant review of standards of the profession, including issues of recruitment, patterns of employment, standards of training. In 2006 the "Professional Issues and Standards Committee" appeared again among MSS committees, charged with responsibilities previously assigned to this committee and to the Academic Freedom and Responsibility Committees.

Committees on Application of the Discipline

In addition to research, application of the sociological discipline has occurred primarily through teaching. In more recent years, sociological practice outside of academia has been given significant attention.

Committees on Teaching

As was reflected in some of the very early *Mid-West Sociologists*, teaching has long been a primary focus of MSS members. Yet it was not until 1973 that the first committee focused on teaching, "Innovations in Teaching Sociology Committee" emerged and continued through 1977. In 1978 the "Committee on Undergraduate Education" was

appointed and continued (starting in 1996 the Undergraduate Education Committee—a prime example of a change that probably resulted from a program chair's preference) through 2002. In 2003 the committee broadened its charge to be inclusive of graduate education by changing its title to the "Committee on Teaching and Learning," the name it maintains at this writing. This committee has through the years sponsored annual meeting sessions on teaching and learning and has provided opportunities for members to engage with others to share ideas about teaching.

Applied Sociology/Sociological Practice

Commitment to involving and serving sociological practitioners took form as the "Ad Hoc Committee on Applied Sociology" in 1998 and was followed in 1999 by the "Ad Hoc Sociology Practice Committee." Since 2000, the "Sociological Practice Committee" has been a standing committee of the MSS charged with exploring ways in which clinical and applied sociology can be highlighted within the MSS.

Technology

By 1998 academics generally, and sociology specifically, was pushed to consider the implications of technology for our profession, and to determine how to best use and control these new tools for teaching and practice. During this formative period, committees of the MSS addressed the issues of technology. In 1998 an "Ad Hoc Committee on MSS Website Technology" was appointed largely to make input on the new Society Website. The next year the committee was broadened when it became the "Ad Hoc Technology Issues Committee" and in 2000 the "Technology Issues Committee" became a standing committee. The Committee not only oversaw the Website, but offered sessions designed to acquaint MSS members with new technology-based pedagogical tools. As technology became more integrated in the professions, the committee was disbanded in 2006.

Social Issues and Action Committees

Not surprisingly, members of the Midwest Sociological Society have been involved with the many social and political issues that have surrounded its 75 years of existence. Many of the Society's committees have reflected commitment to taking stands on such issues and to ensuring that the organization made efforts to ensure that the profession responded to the societal changes as well.

Resolutions: The "Resolutions Committee" was included in the 1962 program. For many years a tradition in the MSS, as in many organizations, was to present and vote on

pro forma resolutions citing the accomplishments and work of the many individuals and groups that had contributed to the meeting.

But more interestingly, the "Resolutions Committee" also served as a conduit for more controversial, often political resolutions. These often related to support for political positions and causes as well as for welfare issues such as supporting union efforts. Resolutions also occasionally were presented and voted on to push the MSS Board to particular actions. The Resolutions Committee ceased to exist in 1998, after a number of years of entertaining nothing but the pro forma resolutions.

Committees on Women: In 1971 the "Subcommittee on the Professions concerning the Role of Women in Society" appeared. This subcommittee, presumably a subcommittee of the Committee on the Profession, was active for three years. In 1974 the "Committee on Women in the Profession" appeared in the program, to be supplanted the next year by the "Committee on the Status of Women" for one year, before returning to its 1974 title. In 1993 the title changed to the "Committee on the Status of Women in the Profession," a name that was maintained for six years. In 1999 the committee name returned to "Committee on Women in the Profession" then in 2007 was given its current title, "Committee for Women in the Profession."

Over the years, the committee has taken responsibility for raising issues related to the status of women in the profession through sponsoring sessions on issues related to gender and to monitoring the status of women in the profession. Research by the committee has appeared twice in *The Sociological Quarterly*.

Minority Scholars: In 1985 the Board of the MSS appointed a "Task Force on Minority Scholars" that continued for six years. In 1991 the Minority Scholars Committee emerged as a standing committee of the MSS. The committee has been active in bring to the Society information about issues of underrepresented groups in the discipline. For many years they sponsored the Welcome Night reception, proceeds from which sponsored the MSS/ASA Minority Scholar.

Social Action Committee: The "Social Action Committee" first appeared among MSS standing committees in 1987. It may have been responsible for the demise of the "Resolutions Committee" a few years later as it assumed responsibility for identifying and bringing forward social action recommendations to the members. The committee continues with a charge to take under consideration proposals for social action. It also sponsors and selects recipients for the annual MSS Social Action Awards.

Student Issues: From the earliest meetings of the MSS the Bulletin of the Mid-West Sociological Society reported on the number of student members. Volume III, #1 of the Bulletin of The Mid-West Sociological Society reported on a session held at the 1940 meeting in Des Moines.

"Approximately one hundred students attended the student session of the Mid-West Sociological Society on Saturday, April 20, 1940. Eighty-three students from sixteen colleges were registered. Forty-one students from fourteen colleges joined the new society immediately. The meeting was characterized by lively discussion."

The Mid-West Student Sociological Society was formed at that meeting with a President, First and second vice presidents, secretary and treasurer. The new group passed three resolutions: 1) asking that the MSS "establish and maintain a list" of scholarships, fellowships, assistantships and positions for the benefit of the members of the Mid-West Student Sociological Society, (2) calling for expression of appreciation to the Mid-West Sociological Society for the privilege of attending the MSS meetings, and (3) thanking Miss Marguerite Reuss and the student organization committee of Marquette University for working to establish the Mid-West Student Sociological society. In 1941 there was a major initiative to form Campus Sociological Clubs at all Midwest colleges and universities. That group disappeared after a few years.

Through the 1990s and early 200s, student directors of the MSS assumed responsibility for planning activities for student MSS members. Then in 2003 the "Student Issues Committee" became a standing committee of the Society.
